Diana Papoulias

“Intersex Bass”

Diana Papoulias is a Research Fish Biologist with 22 years at the US Geological Survey's Columbia Environmental Research Center (CERC). She began her career in fish biology working in fish culture in the United States and in Mexico. Dr. Papoulias later got a master's degree at Arizona State University and worked on native endangered Colorado River fishes, specifically larval fish ecology. She received her Ph.D in 2001 at MU for her research at CERC that focuses on the effects of environmental stressors, particularly endocrine disrupting chemicals, on fish reproduction.

Dr. Papoulias will be presenting about her research on the occurrence of intersex in fish populations and the potential causes.

## President's Corner

The following is the outcome of our discussion last meeting regarding the Hinkson Creek issues facing the City of Columbia.

“To The Honorable Mayor Bob McDavid:

We, as representatives of the 300+ member of the Mid Missouri Chapter

of Trout Unlimited, write to express concern regarding the City Council's vote to oppose Hinkson Creek stormwater limitations proposed by the Environmental Protection Agency. While we recognize that control of increased stormwater runoff that has resulted from development within Columbia would result in considerable expense to the City of Columbia, Boone County, and the University of Missouri, we believe taking a stance of simply opposing the plan is likely to only delay implementation of controls, while simultaneously adding legal costs as a result of inevitable lawsuits. At the same time, citizen enjoyment suffers from the environmental degradation caused by sediment and pollutants carried into the Hinkson Creek by stormwater runoff. Rather than simply opposing the EPA regulations, we encourage the City and other entities affected by these regulations to be proactive in proposing a plan to mitigate stormwater runoff and the associated water pollution. Hinkson Creek is a gem of the city. The abundant undeveloped public

land bordering the creek and its trail system makes it a joy for use by walkers, birdwatchers, and anglers. Unfortunately, that gem is significantly tarnished during runoff events that can result from even moderate rainfall. We encourage you and other members of the Council to reconsider this issue and move proactively toward improving the quality of Hinkson Creek.

### **Useless training aids - Royal Wulff Wristlok, Ross Perfect Cast, & other wrist-splints.**

As a Federation of Fly Fishers (FFF) Master Casting Instructor, I have seen these things come and go. Fundamentally, they only present *potential* value for about

five practice casts, and NEVER while fishing.

Continued use interferes with developing the neuro-muscular control to adapt to casting situations. One might invoke the most negative connotations of the term "crutch" in seeing the way inexperienced instructors sometimes apply them. Controlling the amount and timing of wrist rotation may be the most essential skill of versatile casting. Some people would like to rely on (or blame) a device for failing, when the fact remains that it is *they* who failed to develop the discipline and then skill.

Whether leather and expensive or simply tucking the rod butt into long sleeve shirts, the result is adequate, the risk is omnipresent. Plus, one could tie a square knot in a Bungee-cord and save a lot of money to then apply to proper casting instruction. (Speaking of casting lessons - FFF Certified Casting Instructor, Jeff Trigg and I will be donating high-quality casting instruction at the TU Banquet on February 18th, 2011)

In a charity class I taught, we took scissors to a Velcro-close, neoprene gravel guard and made four "wrist controllers" out of one. Average price per device was a lot less than you'll pay for commercially marketed versions.

My casting instruction, alone, will not improve your fly casting; ***practicing well & often***, that which you have learned, is required. - **Gary Eaton, MCCI for instruction contact**
