Citizen Alert – Missouri Deer Herd

Governor Nixon recently vetoed two pieces of legislation that would have transferred regulation of captive deer in Missouri from MDC to the Department of Agriculture. He vetoed Senate Bill 506 and House Bill 1326 because it contradicts existing constitutional authority for fish and wildlife through the Conservation Commission by classifying captive deer as livestock and transferring regulatory authority to the Department of Agriculture. In addition, the Governor felt it was not reasonable for only 3 dozen captive deer herd owners to jeopardize the health of the Missouri deer herd should chronic wasting disease continue to spread in Missouri.

To quote one of our TU members and leaders, Mike Kruse, "While not an aquatic issue per se, I urge all of you as individuals, to support these proposals. What is really at stake is the ability of state and federal conservation agencies to manage the public's wildlife (and fish) resources. Unless the silent majority of conservation-minded citizens speak up to support regulations such as these, the wellfunded, well-organized minority, which is interested only in profit, will determine the future of conservation in North America."

You are urged to provide comments to your elected officials on this issue. Following is language for a short letter. A hand written letter is much more effective than an email.

"I do **not** support an override of the Governor's veto of Senate Bill 506 and House Bill 1326 because the language classifying captive deer as livestock is unconstitutional."

Autumn Reading by Bill Lamberson

While we are all waiting delivery of John Gierach's new book, All Fisherman are Liars, I recently was in Tom Hargrove's shop and picked up a couple books to occupy me until Liars arrives. Neither of these books is going to tell you how to catch more or bigger fish, but they may fill the gap between hatches. Jerry Kustich has delivered his third book of essays, Around the Next Bend. Kustich was one of the bamboo rod builders at Winston, who as a group left Winston in protest over changes in company policy. He, along with Glenn Brackett and others, moved across the river in Twin Bridges and set up shop as Sweetgrass Rods. I have had the pleasure of visiting Sweetgrass and find them, like their mentor former Winston owner Tom Morgan, incredibly open to sharing information. The title of Kustich's book reflects that transition as well as the loss of his wife of many years. Kustich muses on these events in his essays and he tells some good fishing stories as well. The essays are somewhat uneven in quality, and as in his other books, can be a bit dark at times. He and his brother Rick are well known especially in the world of steelhead fishermen, and in this book Jerry is best in the steelhead stories, especially comparisons between Great Lakes and west coast fishing.

The second book is in the genre of fly fishing fiction (but aren't all fish stories fiction to some extent?). Scott Richmond is a well-known Oregon fly fisherman and has written a number of guide books on Oregon waters. This book, River in the Sun, is part fly fishing, part spy thriller. It is an enjoyable way to pass a few hours, but you aren't likely to remember it next month. The best part of the book is that he gets the fly fishing right, down to the specific rocks and runs of the Deschutes. Those of you who have floated the Deschutes and spent time hanging around the small towns on the east side of the Cascades will feel right at home. Richmond isn't going to replace le Carre as a writer of spy novels any time soon, but if you

can't get on the water and need to pass some time, this book will fill the bill. If you are headed out west (way out west, not Colorado) to fish, check out Richmond's website: http://www.west-fly-fishing.com/cgi-bin/home.
