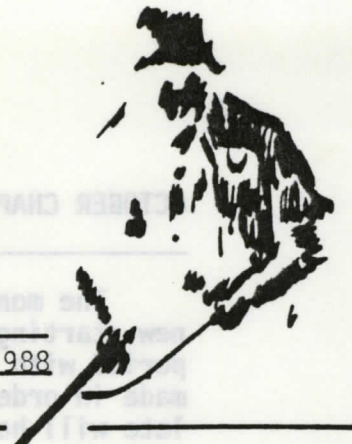

MID-MO CHAPTER MEMBERS WIN NATIONAL AWARD

Spencer Turner and Ed Sullivan have each received two of Trout Unlimited's highest honors. Spence received the Professional Trout Award and Ed the Non-Professional Trout Conservation Award at the TU National Convention in Jackson, Wyoming last August.

The awards read: "For distinguished and dedicated service to the national conservation policy and the cause of the coldwater fishery resource, and for the improvement and perpetuation of the recreational qualities of fishing on the American continent."

The Professional Trout Conservation Award was given to Spence Turner in recognition of his years of dedicated service as the coldwater biologist for the Missouri Department of Conservation. He is the one responsible for the fine trout program we have in Missouri. His innovations in trophy trout management, wild trout, catch and release and trout park areas have created good trout fishing for all Missouri anglers. Upon receiving his award, Spence reminded the members that the future of trout fishing is in Trout Unlimited's hands.

The Non-Professional Trout Conservation Award was given to Ed in recognition of his work these past several years. Ed has provided leadership for the Spring Creek Tree Planting Project. He was also the first President and founder of the Mid-Mo Chapter. Ed accepted the award on behalf of all of you who have worked so hard on Spring Creek.

OCTOBER CHAPTER MEETING

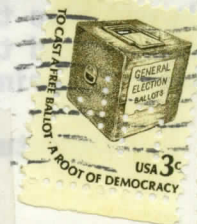
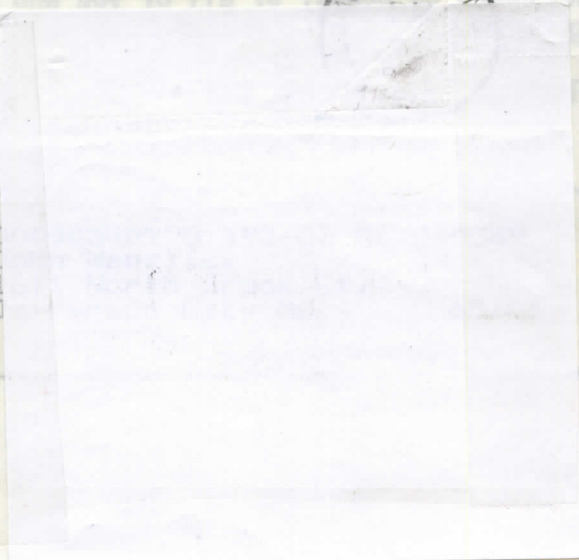
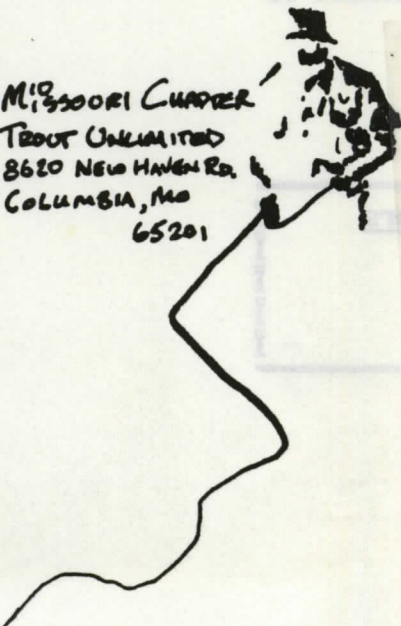
